Grand Council Members Report To 45th Convention

The latter three, who requested not to be candidates for re-election, will turn their duties over to their successors in the Fall.

Having been called to the office of Grand President of Gamma Phi Beta following the resignation of Ursula Owen, Evelyn Gooding Dippell brought to this position a wealth of experience in sorority affairs and a capacity for hard work which has seen much progress made in the past biennium.

New chapters installed have been Beta Xi at Ohio State University and Beta Omicron at Oklahoma City University. A third chapter, Beta Pi, will be installed this fall at Indiana State College at Terre Haute, Indiana.

In the field of publications, announcement is made of the new Song Book, ready for distribution this fall and the Handbook for Gamma Phi Betas which was distributed last year. Revision of the *Convention Manual* and *Province Officers' Manual* has been supervised by Mrs. Dippell. "Crescent News," a rushing aid, developed by Ruth Bartels Fox was sent to all chapters in August, 1951 and will be an annual publication. Under the direction of Margaret Stoddard, International Scholarship chairman, an attractive booklet, *Honors in Gamma Phi Beta*, was published in September, 1951.

A new International Committee on Housing was formed to supervise building and remodeling, and Marion Bebb Howe, former Chairman of Finance, was appointed as chairman.

The Service Roll to honor Gamma Phi Betas who have given long, devoted and constructive service to the sorority was created by Grand Council and approved by the 1952 convention.

In order to evaluate and direct Gamma Phi Beta's philanthropic program, the establishment of a Philanthropy Board was recommended by Grand Council and approved by the 1952 convention. Secretary has seen renewed interest and enthusiasm among alumnæ members.

As of April 25, 13 new alumnæ chapters have been chartered, bringing the total number to 117. Mrs. LeMaster's able direction of the Province Alumnæ Secretaries has brought alumnæ Chapters into closer contact with the International organization.

Mrs. Stuart K. Fox, Chairman of Provinces, reported that Province V had been divided due to its great size, and that there are now 11 provinces with a director and Alumnæ Secretary working in each. Province conferences, which were held in the Spring of 1951 had as their theme, "Loyalties," and were under the direction of Mrs. Fox and the Province officers. A school for Province officers was held prior to the convention, emphasizing correct advisory procedure in rushing and in general chapter operation.

N.P.C. Delegate Mrs. George Simonson will serve as Treasurer of the Executive Board of N.P.C., whose offices rotate among the membership. Since Board members do not serve on committees, Grand Council appointed Beatrice Locke Hogan, former Council member, as a special delegate to N.P.C. She is presently serving on the Citizenship committee.

* Miss Mary Jane Hipp, Secretary-Treasurer of Gamma Phi Beta, reported on the new location of Central Office in Chicago as a satisfactory move. The convention program contained a complete financial report, as examined by Arthur Andersen and Company for the year ending July 31, 1951.

A tentative budget for 1952-53 was presented by Mrs. Howard Newman, Chairman of Finance and a complete report in the field of expansion was given by the Chairman of Expansion, Mrs. John M. Curtis. \Im \Im

Women in a Democracy

"Education Is Such A Dangerous Thing"

(Based on a speech given at the Honors Luncheon June 26, 1952 at the 45th Convention of Gamma Phi Beta, Coronado, California by Dean Alice Hoyt of the University of California at Berkeley. Miss Hoyt is a member of Gamma Phi Beta, Eta chapter.)

I N THE early days of education for the working classes in England and America, George Bernard Shaw spoke these words, "Education is such a dangerous thing." But we have discovered it to be dangerous only if it is not used correctly.

Education is something one must achieve. It is not administered to you. No one can make you an educated person. To be truly educated is to have mastered the art of self discipline in study, in interpretation, in knowledge and in wisdom.

Certain tools are available for the job of becoming educated. Your brain, your body and your books are tools. Teaching you to use those tools effectively are your instructors, but from this point on the responsibility for education rests with one person yourself! Whether you "go through college" or become educated in your college years depends completely on you. The former implies an exposure to many courses (as many snap courses and easy professors as the elder sisters can recommend!) The latter insists upon a sense of devotion and commitment to the educational processes and is an outgrowth of an honorable element in our lives.

Honors should come only to those who work and study and who develop from their own limitations. But honors are also bestowed upon those who have the uncanny knack of knowing just what questions will appear on an examination, and who can write an A paper. Would you call a parrot an educated bird? Certainly not, for words which are heard, then repeated

without having made any imprint on the mind or the soul are the hollow echoes of a short circuit. Would you say that a diploma or an honor society key were the marks of an educated person? Not necessarily!

Then you may ask, who is to judge whether an honor is deserved? Just as the responsibility of becoming educated depends upon oneself, so the sole judge of one's honors is oneself. In the process of becoming educated, we also become mature. And with maturity comes the ability to search our own souls and discover truthful answers. And once we seek these truths, we become endowed with a great humility, for we know then, through our own deep personal discovery, that one never becomes a completely educated person. For no matter how great a fund of knowledge we have achieved, there is

always more waiting to be added to ourstore.

The humble seeker after knowledge will understand the fervent desires of a young graduate of the College of California who spoke the following words in closing his commencement oration in 1869:

"We ask to be initiated, to go behind the scenes. We cannot be content now, with looking at the 'show pictures' and nothing more. We seem to have come into a great and beautiful city. Its stately dwellings, its massive temples, its spacious courts, its long arcades and corridors are wonderful; but their charm for us now is, that they are the shadows of another city that lives within them, a city of the soul. We cannot be willing, then, to remain in the streets, nor to have entered some vestibules and ante-chambers where we have caught glimpses and broken cadences of a harmony and of a beauty which we cannot understand. We must go inward still."

Service To Humanity - A Byword Of Every Alumnae Chapter!

PRIDE in the philanthropic endeavors of local alumnæ chapters swelled visibly when reports of three chapters were read to the convention delegates. Time did not allow reports from all 117 chapters, but the fact that each of these chapters expends time and money to alleviate the suffering of those less fortunate indicates that Gamma Phi Betas everywhere are assuming their responsibilities of good citizenship and service to humanity. Nathalia Field Holland of the Evanston-North-Shore chapter reported on their Ridge Farm project.

Ridge Farm Preventorium in Lake Forest, Illinois, a delightful spot on a wooded knoll of 27 acres, is one of two schools of its kind in the United States engaged in caring for dependent and neglected chil-

dren of all races and creeds—from six to ten years of age. Children from the narrow streets and dirty alleys of Chicago's sprawling back yard. Children born to neglect and poverty and sorrow . . . who have never learned to laugh, who are classified in sociology textbooks as "difficult." Children who are inscribed in police records as "juvenile delinquents." Children with high I-Q's and nothing more. Think of it! Just the right combination of undisciplined intelligence to produce a future Public Enemy No. 1!

Gamma Phi Beta has long been interested in the needs of little children as evidenced by the splendid work being done nationally in the two camps at Denver and Vancouver. In addition to this work, the North Shore area felt the need of a project close enough to home that personal participation in its activities would be possible. This need was fulfilled in the selection of Ridge Farm as the local philanthropy of the Evanston-Northshore alumnæ chapter. The immediate past president of the Ridge Farm executive board is a well-known Gamma Phi Beta, Mrs. William T. Schroeder, Gamma, a member of the Lake County alumnæ group. Phillis Lambert Stefan, Epsilon, also a member of Lake County group, served on the Junior board.

Funds are raised annually through a Benefit and presented to the Farm for support of its summer recreational program . . . one of healthful, life-giving play under trained supervision—something these emotionally disturbed children would never have if Gamma Phi Beta did not provide it—as confirmed by the following quotation from a letter received recently from Mr. Hans Kleinke, executive director of Ridge Farm, "I am happy, in accordance with your stipulation, to be able to use the money for the children's summer program which, unfortunately, does not find in our budget the recognition it deserves." Last summer 'his check not only provided the full-time services of two trained leaders, often selected from the ranks of Gamma Phi Beta, but paid for new play-ground equipment and several summer camping trips to points of interest in Illinois and Wisconsin.

The Ridge Farm Benefit is the big social event of the alumnæ year. Under the supervision of the Chairman of Ways and Means, approximately 40 Gamma Phi Betas are drawn into active work on this project. Help on the benefit last year was given by the Lake County group—both in the planning and the selling of tickets.

In addition to the spring benefit, Gamma Phi Beta gives annually a large Christmas party at the Epsilon chapter house for the 25 children housed at the farm. This year it is under the supervision of the Ridge Farm Chairman, Mrs. Sterling Tremayne (Mary Alt, Phi). It generally comprises a large Christmas tree with individual gifts for each child, and large toys and games given to the school as a whole for use of all the children, a Santa Claus, refreshments and entertainment. The Greek Letter chapter girls enjoy helping with this project and last year volunteered their services to collect, repair and paint toys for the party. In addition, 35 alumnæ gave their time to make the party a success.

Just as Gamma Phi Beta is dedicated nationally to the cause of youth advancement toward better health and a better way of life through its camps for underprivileged children, the Evanston-North Shore alumnæ group now further that cause in their own local support of the children of Ridge Farm. And the Benefit whose original purpose was to raise funds for this worthwhile philanthropy has served to build public interest in Gamma Phi Beta.

Jeanne McMakin Hespen of the Tucson alumnæ chapter told of the aid her chapter has given to the Arizona Children's Colony, a new state home for mentally deficient children. (THE CRESCENT of September 1951 carried a story on this philanthropic project.)

Gail Skogmo Edwards, president of the Minneapolis alumnæ chapter, spoke of that chapter's adoption of the Minneapolis Curative Workshop as their project. The Workshop offers a rehabilitation center with a combination of Physical Therapy and Occupational Therapy. Facilities are used to decrease or eliminate physical disability, to renew the patient's confidence and hasten his re-adjustment to a life of usefulness and independence.

Over \$1200 have been donated to the Workshop by the Minneapolis chapter, part of which was used to purchase an electric kiln and clay and part to help pay for a full time employee. The chapter voted recently to set a goal of \$500 as an annual contribution to subsidize this worker's salary.

Each year the chapter president appoints a Curative Workshop chairman, who secures volunteer workers and supervises plans for the fund-raising dance. The newly organized Junior alumnæ group has already supplied many volunteer workers, and will assist this year in raising funds.

The work of the volunteers is not tedious. The four hours spent every other week are filled with such tasks as hot packing patients, giving whirlpool treatments, light treatments, changing and counting linen, helping with files and assisting the paid aides wherever needed.

"Volunteer Workers," says Mrs. Edwards, "leave the workshop with the gratifying feeling of having helped . . . of having heeded the words of George Eliot, "What do we live for if not to make the world less difficult for each other." D D D

The following month, they were adopted and the following officers elected: President–Mrs. E. E. Grossman, Gamma Phi Beta; Vice President–Mrs. A. B. Urguhart, Alpha Chi Omega; Treasurer–Mrs. J. E. Dillard, Kappa Delta; Corresponding Secretary–Miss Minnie Franck, Kappa Kappa Gamma; Recording Secretary–Miss Mary Weaver, Delta Delta Delta; Historian–Mrs. N. H. Henry, Phi Mu.

T Autumn calendar-November 4 and December 15.

November 4-America votes! Radio and TV won't let you forget that!

What about December 15?

Why, that's Bill of Rights Day. Too little is known about that great document, the Bill of Rights, proposed by Congress on September 25, 1789 and ratified and declared in force on December 15, two years later in 1791.

The Bill of Rights, which is incorporated as the first ten amendments to the Constitution of the United States, enumerates the privileges and immunities of all people, whether citizen or alien. These are: freedom of religion, speech, press, assemblage, and petition of redress; freedom from unreasonable search and seizure, from violation of the security of person and home; freedom from arrest except by warrant, from trial a second time for the same crime, freedom from witnessing against oneself, and from deprivation of life, liberty or property without due process of law; also freedom from excessive bail and fines and from cruel and unusual punishments.

To many people, then and now, the Bill of Rights is the nugget

of gold in the Constitution. Some of the States refused to ratify the Constitution until assured that these amendments would be made a part of it. It is the Bill of Rights which safeguards the privacy and freedom of the individual—and that means yours and mine too!

However, many a TV panelist would muff his question if asked who is the author of the Bill of Rights.

Certainly, George Mason, said to have had one of the finest minds of Colonial Days, has received only casual attention until recent years. In the Preamble to the Virginia Declaration of Rights, which was his most noted writing, occurs the basis of these first ten amendments to the Constitution, known as the Bill of Rights. He is thus recognized by some historians as the Author of the Bill of Rights. presentation, accompanied by a color guard from all the women's Armed Forces. 
Every day to more Americans the privileges and responsibilities of their Citizenship become dearer as they think. You can understand your citizenship rights better by being thoroughly acquainted with the Bill of Rights. At an opportunity, visit Gunston Hall, perpetual memorial to George Mason and the principles for which he stood. This Georgian plantation house, well known to architectural students of the Colonial period, has rooms of outstanding richness and beauty. Particular attention should be given the beautiful gardens of 18th century designs with magnificent box hedges planted by George Mason himself.

The vision of George Mason and his contemporaries who gave us this immortal document, is startling in the power and influence it has exerted over the lives of Americans from the early days of the founding of our Republic to the present when it is becoming of even more vital interest. Conditions have changed

> since the days of George Mason, but not the fundamental nature of human beings. Back in the early days of this Republic, George Washington wrote: "We ought to deprecate the hazard attending ardent and susceptible minds from being too strongly and too carly prepossessed in favor of other political systems before they are capable of appreciating their own." How significant this statement is for us in these times.

Does Freedom mean "Do as you please?" Some people think so, as evidenced by the mob psychology displayed on hundreds of Campuses last spring which discredited the aspirations of students asking for more authority and for permission to sit on Administrative Committees of their Colleges. No freedom may be safely granted to officials or groups, young or old, with-

Indicative of this growing interest was the gathering of persons from many states last spring to participate in the wreath laying ceremonies commemorating the birth of this great Virginia Patriot. A Visit To San Diego State College

S AN DIEGO STATE COLLEGE, established primarily as a normal school, and a State Teachers' College until at the present time it has gained status as a full-fledged State College, specializing in various fields of business, psychology, sciences, and arts, as well as the originally intended elementary and secondary teacher education. It was decided in 1936 after legislative action had changed the name of the college to San Diego State College (dropping the word "Teachers'" from the title) that teachertraining courses should not be required of all students. A complete range of degree programs is available in all the liberal arts fields, a number of vocational and pre-professional areas including teaching and the general secondary credential. Masters degrees are given in psychology and other fields where the subject is applied to teaching.

The college is outstanding in its speech arts, education, and psychology curricula.

The present campus, styled in a combination of Moorish and Renaissance architecture, is the third to be inhabited by the student body since the opening of the normal school, an increasing number of enrollments each year creating a need for a larger campus. The site of the campus, ten miles from the center of town was chosen because of its pleasant surroundings and vast acreage, lending itself extremely well to the building expansion program now underway. Plans for buildings to be erected during the summer include a new campus laboratory school, additions to the science departments, and a new wing for the music building.

With the transfer of classes from the old to the new locations, several new traditions and annual events were brought into being. One of the first was the carving of the 400 foot 'S' on Black Mountain behind the college. Each year since 1931 hundreds of freshmen supervised by Oceotl, men's

honorary, have trudged up the slope with buckets of whitewash to perform the annual rite of painting the 'S'. Several nights later at the Homecoming game and pageant the same group again makes the ascent, this time with flares, to light the 'S' for all the returning alums. At last year's homecoming parade Beta Lambda was the proud winner of the trophy for third place in the sorority float division and is making plans for a first place float this year.

Cetza, organized in 1929, at the end of its first active year was the foremost women's organization on campus. Cap and Gown, honorary senior women's organization was founded in 1932. Three members of Beta Lambda are present members of this organization, and last year found our president as Chancellor of Cap and Gown. Virginia Janney has just finished a term as president of Cetza.

Spring Sing is another activity participated in each year. All groups send choruses to compete for prizes in choral and novelty divisions. The Sing replaces Femme Frolics which Beta Lambda won two years ago, as the annual spring event. The perpetual trophy for inter-sorority sports competition has been won by Gamma Phi Beta at State for the last three years, and now is ours to keep.



Awarded by the United States Government as authorized under Public Law 584, 79th Congress, the Fulbright scholarships, because of their generous terms and opportunity for foreign travel, are greatly in demand and highly competitive. Students planning to do graduate work and teachers seeking exchange professorships and opportunities for advanced work are eligible to apply. All fields of academic study are encompassed by the grants. Expenses for the fellowships are borne by the host countries in accordance with the law, which seeks to provide a means whereby money owed the United States Government may be repaid without taking funds out of the various countries involved and international understanding also be fostered.

While at Lake Forest, Nancy has been active in the Madrigal singing group, has been a student counsellor at East House and at Bradley lodge, and has done honors work in English, as well as maintaining a high level of academic work.
