



**NEW BRUNSWICK**—They look like any other female students at Rutgers University. A little more well-dressed than most, perhaps, but then again, almost everyone on campus is dressing up from the battered jeans and frizzy hair of the 1960's these days.

What makes these 46 women unique among other university co-eds here, however, is that they are members of the first sorority in the 211-year history of the state university.

The sorority, Gamma Phi Beta, has evolved over the past three years from a local group with no financial or spiritual backing to a chapter of a national sorority that will pledge its first official class this month (April).

At a time when the tide of feminism runs strong, particularly on the Rutgers campus, and where one school in the university federation, Douglass College, remains adamently for women only, it would seem that any student who joins the only available sorority really has her public relations work all cut out for her.

"In general sororities are stereotyped," said Mary Marko, a Rutgers College junior, who is vice president of Gamma Phi Beta. Her classmates think that sorority members are "snooty and still wear white gloves from the 1950's."

Sororities may well have been just that at one time, which is why so many failed, she admitted. "At a college in the south, you still have to wear nail polish if you belong to a sorority," said Ms. Marko who added that dropping an image like that is not easy.

"At Rutgers, you don't lose that stereotype . . . one pledge asked me 'What kind of girls are you looking for?' "Ms. Marko explained that her sorority contains students from all kinds of backgrounds and that conformity is not the key to becoming a member.

# **Changing Times**

Pam Chesky, the sorority's advisor who herself was a Gamma Phi Beta as an undergraduate at Kent State "before it became famous," said she believes that sorority life has "changed with the times."

By law, discrimination is no longer practiced in sororities, but Mrs. Chesky said that the reasons for joining a sorority really haven't changed over the years. "On a large campus, a sorority offers an alternative to university housing, and builds a continuing relationship with other students that doesn't end after four years of college," she said.

Or, as one student was told by a former sorority sister, "You don't really become a Gamma Phi Beta until you are an alumnæ."

"Ten years from now, I want something to come back to," said Jennifer Cordis, president of the group when it was still just a local sorority.

Sheila McCarthy Hewitt, regional director of the highly organized sorority that began 104 years ago at Syracuse University, said that as you move away from close-knit college friendships, being a Gamma Phi Beta insures that "your friends aren't all going to be just your neighbors or your husband's business associates."

# "One of the Boys"

Presently, Gamma Phi Beta is "one of the boys" when it comes to social and community service activities. The group participates in the same kinds of events that the numerous Rutgers University fraternities share. Princeton Weekend, an event staged around the 108-year-old football rivalry that exists between Rutgers and its Ivy League neighbor, and the Zeta Beta Tau dance marathon for the benefit of the American Cancer Society are two events in which the sorority participates.

The sorority also hosts a Christmas party with a Rutgers fraternity and is involved in the Rutgers Community Action group, a social service organization dedicated to helping local youngsters.

At an informal meeting of about 20 sorority members recently, all of whom wore the sorority's symbolic brown crescent pledge pin, several students talked about the advantages of belonging to the only campus sorority.

"This is a place where I belong, where people accept me," said Diane Todd, a Douglass College junior who is the group's president.

Although she noted her division of the university is against the sorority system, she believes it "improves individuality."

"I'm in a position where I have to talk to alumnæ—it's a constant battle to present yourself in the best light." she said. She joined the sorority because there were no real "social organizations on campus for women."

Linda Kruse said her social life changed "from association with men to making more permanent and lasting associations with women."

"It gets rid of a lot of the fallacies about women being competitive," said Ms. Todd. "These girls are my friends."

Mrs. Chesky pointed out that there is really no difference in seeking out a sorority than in seeking out friends. "I haven't noticed the sorority to be unhappy with any of the girls who have pledged," she added.

# A Lot of Red Tape

Although members of Gamma Phi Beta are excited about the extra dimensions a sorority adds to their university lives, they don't expect that too many other students will be forming sororities of their own. They claim there is just too much bureaucratic red tape. In order to be accepted as a recognized sorority on campus, the women had to apply to the Dean of Fraternity Affairs, the Rutgers University Board of Governors, the Rutgers Fraternity Council and the Alumni Inter-Fraternity Council.

The various university officials involved in the creation of Gamma Phis Beta also delayed giving clearance for the women's group to go national for a while.

"I guess they wanted to make sure we were going to last," said one member.

# RUTGERS UNIVERSITY

New Brunswick, N.J.

On April 23, the 29 fraternities of Rutgers University made way for the first feminine member of the Fraternity Council—Delta Mu Chapter of Gamma Phi Beta. The New Brunswick break-through came in November, 1976, when members of a local sorority, Delta Beta Psi, petitioned and were accepted as the Sorority's 89th chapter.

Those initiated at this historic April event were 26 pledges, including Betty Rolle, one of Delta Beta Psi's three founders; and seven local alumnæ initiates. Participating in the activities were these International Officers: Elizabeth Sloan Phillips, Alumnæ Vice President; Leonite Selzer Moore, Director of Expansion; Marian Corley Hulsey, International Ritual Chairman; Eileen Lindemann Lentz, Province I Alumnæ Director; and Sheila McCarthy Hewitt, Province I Collegiate Director.

Installation services were held in the afternoon at the New Brunswick Sheraton Hotel. And, since the chapter's new-found rock was left in a car trunk, Delta Mu has the distinction of being the first chapter "Founded Upon A Sock." Members of Alpha Chapter installed Delta Mu with Mrs. Phillips and Karen Hedine, collegiate consultant, in charge. Immediately following, a model chapter meeting was staged by Alphas and featured a recording secretary's minutes from the 1800's. There were no additions or corrections.

The Elks Club was the setting for the Pink Carnation Banquet. At that time, Mrs. Phillips presented the charter to Delta Mu president, Diane Todd. Emerald Erickson (William & Mary), president of the chapter's House Corporation Board, served as toastmistress. Special guests included Assistant Dean of Students Charles Coogan, presidents of the Rutgers fraternities, alumnæ, parents and dates. Katherine Nordeen Snyder (Drake), field representative, organized the entire event.

# Many Gifts and Awards

Grand Council's gift to the newly installed chapter was an engraved silver serving tray. Chapter advisers Pam Bosze Chesky (Kent State), Cathy Boudreaux Griffin (Louisiana State), Nancy Kavisic Conway (Missouri) and Rosemary Morel Stafford (Gettysburg) presented two plaques. Other gifts included Delta Mu stationery, flatware, a crystal bowl, silver candlesticks and an intricate needlepoint by Eileen Lentz depicting the chapter's history.

Special awards went to Betty Rolle as founding mother and Jenny Cordes, last Delta Beta Psi president. Each charter member received the Outstanding Pledge Award.

Alpha Chapter also presented Diane Todd with a historic president's badge.

The grand finale was furnished by charter members of Delta Mu who sang "Sisters We"—an original Delta Beta Psi song with a verse changed to Gamma Phi Beta.

With 10 spring pledges to their credit, Delta Mu is now on its way—proving to the fraternities they should "never underestimate the power of a woman."

# SOUTHWEST MISSOURI STATE

Springfield, Mo.

Amid an atmosphere of enthusiasm and determination, the Sorority's newest colony, Delta Nu, was launched in May at Southwest Missouri State University, Springfield. A pledge class of 24 had been organized as a local for only one and a half years, but had an impressive list of accomplishments in that short time. Not only had they received a trophy for outstanding community work, but they'd won the coveted scholarship plaque, taken first in Greek Week Sing, placed third in Sigma Chi Derby Day.

Delta Nu resides on a beautiful campus in the heart of the Ozarks. Enrollment at the school is approximately 12,000. Gamma Phi Beta brings the total Panhellenic membership up to five. Other sororities established there are Alpha Delta Pi, Sigma Kappa, Tri-Sigma and Alpha Sigma Alpha.

The unusual beginning of the new colony is both a tribute to the Greek system and to the girls themselves. In November, 1975, at the urging of fraternity members, five young women formed their own group—their purpose from the outset—to seek the support of a national sorority. It was felt by many, including the school administration and on-campus Greeks, that a new sorority was needed. The fraternity-sorority ratio was 3-1.

The spirit of these girls never wavered as they worked to compete in campus activities and to establish themselves. They rushed, as an associate member of Panhellenic, and pledged more outstanding girls, swelling their ranks to 24.

Many of the girls had Gamma Phi Beta friends and ties, so when they approached the Springfield Alumnæ, wheels began to turn. **Greta Gibson Huff** (Kansas), alumnæ president, took charge of keeping all communication lines open, backed by the support of her group. **Karen Sue Kreider Sweeney** (Kansas) was named local field representative.

In April, Audrey Weldon Shafer (Missouri), past Grand President and first alternate delegate to National Panhellenic Conference, met with the girls and came away with determination. Grand Council sent the Director of Expansion, Leonite Selzer Moore (Southern Methodist) to talk with school administrators, alumnæ and the girls. All were impressed but the school year was drawing to a close.

Here was a ready-made colony with both initiative and desire. Its members wanted to be Gamma Phi Betas. Could the Sorority speed up the process and pledge them before summer?

Grand Council responded affirmatively and the girls were pledged at the end of final week. It was a fitting climax to their year of hard work.



# Sing Out for Scholarship

# A Gammy Exchange of Ideas on how to mix Sorority life and scholarship

From a skit on "Following the Yellow Brick Road to Straight-A City" to a dinner with steak for B-average members and beans for the rest, Gamma Phi Beta chapters use both fun and serious events to promote scholar-ship among members.

In this column, you may find an interesting idea adaptable to your chapter. But, unlike many sorority activities which are group-oriented, scholastic achievement is an individual matter. So an attitude of education's importance probably has a more serious effect on members than any thing else.

# Posies at Purdue

Delta lota encourages each member to work hard on her courses—then recognizes scholastic achievement at an annual banquet. At the beginning of the semester, each member sets her scholastic goals for each course. The women achieving those goals receive a daisy at the banquet. Women making the Dean's List receive a carnation, and those attaining a 6.0 grade average are honored with a red rose. Last spring, the chapter also gave recognition pins for the 6.0 average. If the member maintains the straight-A average for two consecutive semesters, she may keep the pin.

# **Best Scholar Wears Ring**

At Oklahoma City University, the Beta Omicrons emphasis on studying earned them the second highest scholarship rating in the Sorority last year. The chapter has required study halls for all pledges and members whose grades are below the 2.5 average. They must attend two out of every three nights from 7-10 p.m.

Recognition for the highest grade point average is a check to the top pledge to help her purchase her badge, and a traveling scholarship ring. The latter has circulated in the chapter since 1951.

# "Wizard of Straight-A City"

Nebraska University's Pi Chapter uses a skit to promote scholastic accomplishment at their scholarship banquet each semester. Dorothy and her friends find it hard to study with all the partying and dating, but the good study fairy helps devise a way to encourage good study habits.

During the semester, the "Study Fairy" leaves special treats for members hard at work on their courses. Pi also has a "Wise Study Owl" that compliments those members earning good grades on a test or research paper.

# Study Buddies at Bowling Green

The "study buddy" system and study hours must work because at Bowling Green State, Beta Gamma Chapter earned the plaque for the Greek Chapter with the highest grade average. Scholarship chairman, Susan Francis, set up the system so sisters with the same major could work together on any problems they may have with classes.

# **Emphasis Program at Irvine**

Besides study helpers, **Delta Eta Chapter** (California-Irvine) invites speakers to talk about the importance of scholarship and also keeps a file on old tests and research papers from members. They also pledge only rushees with good high school averages.

Delta Etas are working with other Greek organizations through the university's Learning Skills Center on a program of workshops to emphasize academics. Topics will include time management, objective test-taking and reduction of test anxiety.

# Wednesdays Are "Study Nights"

At Northwestern, Epsilon Chapter declares Wednesdays as "study nights" and all members are encouraged to come to the house and study under "all's quiet" conditions.

A file is kept in the house telephone room and it contains an index of all the members' majors and their individual courses for the quarter. A cumulative record of courses taken while at Northwestern also is kept to help anyone who might be having problems in a particular subject. Epsilon also has an up-to-date file of old tests given by professors within a recent period of time.

Quarterly scholarship nights are held. Individuals with a 3.5 average or better are honored as a special dinner. receive a pink carnation.

# Scholarship Support Incentives

Lambda Corporation Board at the University of Washington aids in tuition costs for deserving members. An honorary scholarship, the Blanche Windsor Rice Award, is given annually to a member based on activities and need. The outstanding junior or senior receives the Meany Younger Inspirational Award.

At Rutgers, **Delta Mus** are planning to offer prizes, yet to be selected, as incentives for class accomplishments. They also are establishing a scholarship file and scheduling speakers to increase the chapter's consciousness of the importance of academics.

# **Apple-Polishing Grade Makers**

At Drake, Gamma Upsilon's apple-polishers' dinner recognizes top scholarships for the semester. The most outstanding student wears the chapter's scholarship pin. Too, a stuffed dog is passed around to the room of the "dog-gone" scholar—the member who studies the most hours during the period.

# Steaks for Scholars

At both Memphis State and Louisiana State, Gamma Alpha and Gamma Lambda Chapters hold an annual Steak and Beans Scholarship. Members with a 3.0 grade average or above eat steak—everyone else has beans. At Louisiana State, the diners are segregated—and those at the bean table cut up more than eating.

Gamma Alpha alumnæ and the Memphis State Mothers Club present awards at the informal event: Best Scholarship for a Member, Best Scholarship for a Pledge, and Most Improved Scholarship. Gamma Alphas also find tutors for members who are having difficulty.

Gamma Lambda presents its awards to the women with the highest grade average in each class as well as those for improved scholarship. Most of all, the dinner stands as an incentive. Everybody wants steak!

# Majors List at Kansas

Sigma Chapter's active scholarship program includes

providing pledges with a list of each member's major so they may know where to start for help on their courses. The chapter also publishes a calendar showing the members' test dates so others in the chapter can show consideration for sisters with an added amount of studying.

# Does Sorority Life Cut Down on Studying?

Evidently not at the Gamma Kappa Chapter and many others across the country. The Kearney State group was presented the Panhellenic Outstanding Scholarship award last spring. This award is presented annually to the corority with the highest grade point average. Not only did Gamma Kappa achieve that mark this year, it has managed to stay #1 for three years in a row. Says CRESCENT Correspondent, Jan Riggert, "Sorority life doesn't inhibit studying; it enhances it."

occupations, "panhellenic" associates with interesting volcations. The file should be used in matching alumnæ with collegiates of like interests; in providing a resource of persons to meet with pledges about what is entailed in training for a specific occupation, the opportunities for employment, the reality of the working situation, the need for college preparation (subtle reference to scholarship), and the competition.

The alumnæ would be stressing that Gamma Phi Beta cares for each pledge and potential member her whole life and is eager to provide "educational" resources for her to utilize.

Have a career (vocational) goal evening which could replace or supplement the scholarship dinner. Collegiates would dress as their career goal; alumnæ would be invited to come (they could also be "appropriately costumed"); mixing would be informal and fun . . . a clever way to get acquainted. A competition for best career protrayal in each class, with prizes, could be an optional feature.

Recognition of career accomplishments of collegiates and alumnae should be incorporated into meetings, newsletters, etc., when most timely. Alumnæ examples: a doctor's office opened, realtor examination passed, election to office in a professional group, committee chairman in Junior League, promotion within a corporation. Collegiate examples: recipient of special scholarship, accounting internship received, admission to law, medical or graduate

# YOUR WHOLE LIFE THROUGH...

Since more and more young women leave college with their eyes on a career, an alumnæ group gathered at the Seattle Convention went so far as to suggest expanding—even replacing—traditional scholarship dinners with career goal programs.

Scholarship, obviously, was the #1 concern of the 30 representing alumnæ sponsored collegiate chapters. But, they noted, the word "scholarship" often has a threatening connotation and, too, scholastic achievement is largely an individual matter. Diversity of interests and pursuits complicates scholarship programming and frequently there is no alumnæ adviser for scholarship.

So the goals they set were to improve pledge education, scholarship programs and alumnæ-collegiate relations by developing a career planning program. Themes suggested were "We Care for You Your Whole Life Through" and Gamma Phi Beta CARE(ER)S—ER being your Educational Reputation."

# Three Major Objectives Defined

Establish and/or maintain a card file on alumnae containing these data: college major, professional background (active employment, full-time housewife and mother, volunteer), current occupation, husband and/or children's


# Two Out of Three in St. Louis

# DESIGNER OF JIM THORPE MEDAL FIRST WOMAN ON TULSA CC BOARD

As president of Frankoma Pottery, Joniece Frank (Oklahoma) was a natural choice to be the first woman member of the Board of Directors of the Metropolitan Tulsa Chamber of Commerce. She's also the first woman president of the Tulsa Area Manufacturer's Club.

Located in Sapulpa, the pottery firm was founded 43 years ago by Joniece's father. It's not surprising that she says she always knew what she wanted to do. "I was born into the pottery business . . . I have clay in my blood."

She went on the payroll when she was 12, working in the showroom. Later she moved into the mold shop—then through practically every other department at Frankoma. She believes familiarity with all operations of a business is necessary to achieve success.

In addition to her responsibilities as chief executive of the company, Joniece spends countless hours at the potter's wheel creating new designs. Her talent and energy go into everything from a dinner plate to a special order item.

She is on the Board of Directors of the Oklahoma Athletic Hall of Fame and was appointed to the Jim Thorpe Committee to design the medal. It was the first medal ever designed by an Oklahoman to be struck at the U.S. Mint in Philadelphia. In the chief engraver's 42 years at the mint he said it was the only mold in his experience that required no touching up or correction of any type.

Joniece also did the official inaugural souvenir for Governor Boren. She's thrilled whenever Frankoma is asked to represent the state because "... we are Oklahomans using Oklahoma clay."

The firm manufacturers "anything which can be put on a table" — from vases, to tableware to chafing dishes and ashtrays. The basis for all Frankoma pottery is a local red burning clay. After molding, all pieces are applied with a unique glaze in various thicknesses according to pattern and design. This allows the red body to show through the glaze giving it a mottled effect when fired.

# SHE SANG HER WAY INTO CARNEGIE HALL

All the magic and prestige of appearing in New York's venerable Carnegie Hall recently touched **Judy Allen George** (Northwestern). In recital there, Judy sang seven selections of twentieth century music and was reviewed by the *New York Times* as "someone who knows her music and who has the gift of communicating that knowledge in a passionate, engaging way." Another reviewer described her as a "musicianly soprano."

Upon graduation from Northwestern, Judy went to New York City as a member of the Goldovsky Opera Institute. She was helped in her continuing studies by a grant from the Martha Baird Rockefeller Institute.

Presently an Associate Professor of Voice at C.W. Post College, Judy appears frequently in opera and concert. Her recent roles include the Mother in Menotti's "Amahl and the Night Visitors," Mrs. Camoflager in Vittorio Rieti's comedy, "The Pet Shop" and Baucis in Haydn's marionette opera, "Philemon and Baucis." Judy sang in NBC-TV Opera's production of the St. Matthew Passion and debuted as Musetta in "La Boheme."

In the field of contemporary music, Judy has premiered several new works by Raoul Fleskow at Alice Tully Hall and Carnegie Recital Hall. She also performed at the Smithsonian Institute during Washington, D.C.'s Haydn Festival.

# HONORED FOR LEADERSHIP IN EVANSVILLE

Two Evansville Gamma Phi Betas were recognized for outstanding achievement at that city's YWCA Leader Luncheon last spring. Charlotte Bromm Stone (Wisconsin) and Josephine McCarty Clark (Northwestern) were cited for services and contributions to the Indiana community.

Charlotte, completing her 10th year as Curator of Collections at the Evansville Museum of Arts and Science, was honored in the field of art. A former art education major, Charlotte began her work as a Junior League volunteer by mounting prints for art files. Later she helped catalogue the American Indian collection. She's now responsible for care of museum collections, including the city's memorabilia, both pioneer and Victorian.

Another of her responsibilities is serving as registrar; she keeps records of acquisitions and loans to the museum. The more than 3,000 volumes in its library aid Charlotte in assisting with the research of acquisitions, writing labels and disseminating information to the public. She says one of the more fascinating facets of record keeping is the cataloguing of the fine and decorative arts. Meeting young artists and keeping abreast of the contemporary art movements are fringe benefits she enjoys.

Volunteer service as Project Director of Women in Community Service resulted in Jo Clark's recognition. WICS is a nationwide organization of volunteers who, in cooperation with Womens Job Corps, locate, screen and give supportive services to disadvantaged young women. It has had a contract with the U.S. Department of Labor since 1964 to provide these services. Over 50,000 women from poverty level income families have been helped.

Jo has served as Project Director of the Evansville WICS unit since its inception. She devotes 60 hours a week to keeping the unit running and operates it almost single-handedly — there being few active volunteers. This past year, Jo was appointed to the National Board of WICS.

A volunteer worker attributes Jo's success to the fact that she is "so capable and efficient and is so pleasant in dealing with these young women who do not always realize that this may be their only avenue of hope for the future."

# HAWAII GPB "WOMAN OF THE YEAR"

Eileen Garrett D'Araujo was voted Hawaii Gamma Phi Beta Woman of the Year — an award presented at Oahu island's annual Panhellenic gathering.

Eleven years ago, with a degree in zoology, Eileen went to work as a research assistant in the Entomology Department of the famed Bishop Museum. Today, she is assistant editor of the Journal of Medical Entomology.

Eileen says entomology as a career for women is "wide open." In her capacity, she finds her minor in English to be a real asset (the work involves precise writing) and says that editing of scientific journals is a great career for a woman interested in both writing and science. 
