

BETA OMICRON | OKLAHOMA CITY


The chapter spent the semester learning Gamma Phi Beta traditions. Before the end of the year many members were involved on campus participating in dance shows, musicals and fund raisers.

New Jersey



How Are New Collegiate Chapters Started? The Collegiate Extension Process

Collegiate extension is a vital tool for the growth of Gamma Phi Beta. When we start a new collegiate chapter, we increase our chapter roll, total membership numbers and Sorority prestige. New chapters generate additional alumnae, who can serve Gamma Phi Beta and benefit from what the sorority has to offer.

How Does This Happen?

Within an Established Greek System	New Greek System	Acquire a Local Sorority
Panhellenic analyzes campus trends (recruitment registration, chapter size)	University without a Greek system recognizes benefits of establishing one	Local sorority decides to affiliate with a national sorority
Identifies need for additional NPC organization	Selects one or more NPC organizations to establish colonies	Members get approval from university or Panhellenic
Panhellenic or university invites Gamma Phi Beta to campus	Organizations work together to set up new Greek system	Members contact one or more national organizations

In all of these scenarios, Greek expansion must be initiated by the university, and Gamma Phi Beta must be contacted through appropriate channels before a new chapter is formed.

When Does a Colony Become a Chapter?


After several weeks of educational and sisterhood activities and demonstrated stability, colony members are initiated and the chapter is installed. International Council presents the chapter with a charter and officially names the chapter with Greek letters.

What can YOU do to help?

- O Ensure there is a strong alumnae chapter in areas around a university. When a campus opens for extension, one of the first things Gamma Phi Beta measures is the alumnae presence available to help these collegians.
- O Write references! We need alumnae and collegiate members to assist with recruitment on new campuses. Having names of potential new members allows the extension team to reach out to qualified women.
- Recognize that much of this process is out of our control. No matter how badly we want to be at particular universities, we must wait until they are ready.

A New Greek system at the University of Texas - Tyler



After a full semester of Gamma Phi Beta education, Zeta Upsilon Chapter will be Gamma Phi Beta's 116th active collegiate chapter.



Learn from the masters: the art of recruitment

Recruitment. It's a word some women love and others hate. It brings out a strong reaction one way or the other. But what is recruiting besides selling? In an attempt to explore new ways for women to see the benefits of sorority life, we need to seek out the best (or most visible) recruiters. We need to learn from those who have mastered the art. We need a lesson in the art of selling.

Learning from the masters

As in any art, we learn from the masters. Who appeals to what you need most and who is persistent in their messaging? Infomercials. When Chuck Norris and Christie Brinkley smile back, they somehow pinpoint the exact longing you have to be smarter, thinner or coordinated enough to work their amazingly simple exercise equipment.

Be a Gamma Phi Beta recruiter

Think about your job as a Gamma Phi Beta recruiter. Chuck and Christie are paid professionals, but we have prime recruiting periods during the day or evening, while they have late night spots and a limited audience. We can engage in one-on-one conversation and develop relationships and friendships, whereas Chuck and Christie can only smile at a camera. And we have a product that doesn't appeal to just a niche market. We offer the chance to belong to a world-class organization; one founded by women, run by women, and whose main goals are to continue educational and philanthropic endeavors for women.

The secret of selling

And yet, we could learn something from our friends Chuck and Christie. They are put together. They match. They speak clearly and communicate well. They enjoy each other's company and are a true "team." They know the secret of selling is to represent the product they want others to buy.

Remember, you're a role model

Our potential new members look at chapters they visit with the same critical eye. Do I want to be like this woman? Does she represent what I want to achieve? As alumnae, we continue to send the same messages to our younger sisters. They look to us as role models, as women who can build successful careers, families and other volunteer opportunities while still honoring our lifetime commitment to the Sorority. We continue to recruit our already-initiated sisters by exploring new and different ways to make collegiate and alumnae Sorority life relevant.

Inspire new members

So don't be intimidated by recruitment. Don't hide in the back. Get out there, inspire new members with your current achievements and brainstorm new ones together. Remember, you're inspiring tomorrow's leaders and recruiters.

And when in doubt, flip on the tube at night and take a refresher course in the art of selling from our friends in the infomercial.



What is alumnae extension?

Alumnae extension is the process of establishing and reorganizing alumnae chapters and crescent circles in areas where alumnae are clustered but not necessarily organized in a group. This process and the team that oversees it promotes lifetime membership through alumnae leadership and support.



Alumnae groups provide sisterhood, fun, friendship and opportunities for service to nearby collegiate chapters and to the community at large. When Gamma Phi Betas get together, they shine!

How does an alumnae group start?

Alumnae groups begin with interest expressed by local alumnae who want to establish an alumnae support group in their area. The Sorority may also target an area for extension because a collegiate chapter needs alumnae assistance or because of the recognized need for a group in an area where one does not exist.



The Villages, Florida, has a new crescent circle officially recognized by International Council in January. "Our group is so happy to have discovered one other," said Alice Reedy, Crescent Circle Chairwoman.

Who helps gets it started?

Local alumnae work with the Gamma Phi Beta alumnae extension team throughout the extension process. Together, they research and determine the possibility for an alumnae chapter or crescent circle.

How do I start an alumnae group in my area?

Contact International Headquarters to inquire about an alumnae group near you. If one does not exist within 30 miles, the extension process can begin.



Legacy (leg • a • cy)

...a sister, daughter, granddaughter or great-granddaughter (or step-sister, step-daughter, step-granddaughter or step-great-granddaughter) of a Gamma Phi Beta.

...entitled to "special consideration" during recruitment. This means she is invited to the first round of invitational events and, if invited into membership, placed alphabetically on the chapter's first bid list.

A legacy IS NOT...

...invited into membership prior to other potential new members; her membership is considered at the same time as any other potential new member.

...expected to know everything about Gamma Phi Beta. Chapters cannot assume that a legacy does not need to be "sold" on all that Gamma Phi Beta has to offer. Recruit this woman!

A legacy SHOULD...

...be introduced to the chapter via *The Legacy Introduction Form* (at right).

...be encouraged by her Gamma Phi Beta relative(s) to remain open-minded throughout the recruitment process. What was a perfect match for the Gamma Phi Beta "legacy maker" may NOT be a perfect match for the legacy.

...thoughtfully consider all options on her campus; all National Panhellenic Conference sororities share similar goals and ideals.

A legacy SHOULD NOT...

...assume a bid from a chapter simply because she is a legacy. Each collegiate chapter selects new members based on Four Core Values – specific standards for membership. All potential new members – including legacies – must meet these standards, which may be higher on one campus than another.

...be held to higher standards than other potential new members. Chapter members should consider her qualifications for membership just as they do anyone else.

A legacy MAY...

...be worried she won't be valued for who she is. Chapter members should use the recruitment process to get to know all potential new members, including legacies.

...understand the lifetime commitment and general financial obligations of Sorority membership.
...bring an added loyalty to any chapter due to her relationship with her Gamma Phi Beta relative.
...assume that she will be treated fairly and with respect, as any potential new member should.

Leadership: FROM GOOD TO GREAT

Are you a good leader or a great leader? Is your collegiate chapter, alumnae group or Panhellenic association good or great? Jim Collins, in his book "Good to Great", contends that "good is the enemy of great" because the vast majority of us are "good" and it is easy to settle for good. Thus, why would we want to be great when good is good enough?

Moving a group from good to great takes individual member effort and energy. Here are five ways to move your group from good to great:

- Expectations. Leaders must make sure each group member understands rules, procedures and expectations. It is virtually impossible to be a great group if individuals do not understand what is expected of them.
- Actions. Members must recognize that individual actions reflect on the group. Because actions speak louder than words, every member must model the group's values.
- Recruitment. To be a great group, you must recruit great members, individuals who exemplify group values.
- 4. Leadership. Great leaders learn about each group member and her strengths, and then use those strengths. Collins' book observed that good-to-great leaders first got the right people on the bus, the wrong people off the bus, and the right people in the right seats, and then figured out where to drive the bus.
- 5. Commitment. Being a Gamma Phi Beta and Panhellenic member is both a privilege and a responsibility. Membership brings a lifetime of friendships, experiences and opportunities. Commitment means sharing time as a volunteer, paying your alumnae dues, writing references for potential new members, participating in conferences and conventions and contributing to the Gamma Phi Beta and NPC Foundations.



"Helping others is the center of my service to the community. As a mom I wanted to make sure that the voice of the younger generation was heard."








who each day embrace duty, honor, sacrifice," says bestselling author W.E.B. Griffin.
